

AirBeamTV Privacy Policy v.002 - April 5th, 2022

About Screen Recording and Privacy

Any content that you sent to a TV or a Media Device on your Local Network by means of screen mirroring, which is based on Screen Recording and Audio Recording, we don't record into files and we don't send this content to a server outside of your Local Network. We only temporarily store data in the memory of your MacOS or iOS device, before it is streamed to a TV. Upon streaming to a TV or another Media Device in your Local Network, the content is removed from the memory of your MacOS or iOS device.

About Your Media

Your photos and videos (e.g. in your Apple or Google Photo Library) are only accessed by our apps when you explicitly request that. For example, to show them in the stream playing on your TV. In most cases we only temporarily store data in the memory of your MacOS or iOS device, and remove it after the requested function completes. In some cases we cache data within the app on your MacOS or iOS device for a longer time to improve performance. Most apps never send your media to servers outside of your Local Network. The apps working via the external servers don't save your media, only transfer them between your devices. Your photos and videos are always under your full control.

Data Controller and Owner Types of Data collected

Among the types of Personal Data that this Application collects, by itself or through third parties, there are: Cookies and Usage Data. Other Personal Data collected may be described in other sections of this privacy policy or by dedicated explanation text contextually with the Data collection. The Personal data may be freely provided by the User, or collected automatically when using this Application.

Any use of Cookies - or of other tracking tools - by this Application or by the owners of third party services used by this Application, unless stated otherwise, serves to identify Users and remember their preferences, for the sole purpose of providing the service required by the User.

Failure to provide certain Personal Data may make it impossible for this Application to provide its services. Users are responsible for any Personal Data of third parties obtained, published or shared through this Application and confirm that they have the third party's consent to provide the Data to the Owner.

Mode and place of processing the Data

Methods of processing

The Data Controller processes the Data of Users in a proper manner and shall take appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data. The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. In addition to the Data Controller, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of the site (administration, sales, marketing, legal, system administration) or external parties (such as third party technical service providers, mail carriers, hosting providers, IT companies, communications agencies) appointed, if necessary, as Data Processors by the Owner. The updated list of these parties may be requested from the Data Controller at any time.

Place

The Data is processed at the Data Controller's operating offices and in any other places where the parties involved with the processing are located. For further information, please contact the Data Controller.

Retention time

The Data is kept for the time necessary to provide the service requested by the User, or stated by the purposes outlined in this document, and the User can always request that the Data Controller suspend or remove the data.

The use of the collected Data

The Data concerning the User is collected to allow the Owner to provide its services, as well as for the following purposes: Access to third party accounts, Analytics, Displaying content from external platforms and Interaction with external social networks and platforms. The Personal Data used for each purpose is outlined in the specific sections of this document.

The rights of Users

Users have the right, at any time, to know whether their Personal Data has been stored and can consult the Data Controller to learn about their contents and origin, to verify their accuracy or to ask for them to be supplemented, cancelled, updated or corrected, or for their transformation into anonymous format or to block any data held in violation of the law, as well as to oppose their treatment for any and all legitimate reasons. The Data Controller reserves the right to make changes to this privacy policy at any time by giving notice to its Users on this page. It is strongly recommended to check this page often, referring to the date of the last modification listed at the bottom. If a User objects to any of the changes to the Policy, the User must cease using this Application and can request that the Data Controller remove the Personal Data. Unless stated otherwise, the then-current privacy policy applies to all Personal Data the Data Controller has about Users.
